



RED-X Anti-Slip floor treatment

Application Instructions - Buffer Instructions

YOU MUST TEST A SMALL AREA BEFORE PROCEEDING WITH THE INSTALLATION OF RED-X™ TO DETERMINE THE CORRECT AMOUNT OF DWELL TIME

COMMERCIAL APPLICATION INSTRUCTIONS **FOR LARGER AREAS**
ALWAYS WEAR GOGGLES, GLOVES, AND SLIP RESISTANT SHOES WHEN USING THIS PRODUCT.
Follow all proper procedures per your company requirements and guidelines.

STEP 1: Read directions on data sheet carefully before using.

STEP 2: Sweep the floor thoroughly.

STEP 3: Wearing slip-resistant shoes, degrease the floor using clean water and a commercial grade degreaser. Do not use bleach or a power detergent! Be sure to rinse the floor after degreasing.

STEP 4: Pour **RED-X** into a clean, empty mop bucket. Mark off area no larger than 300-500 sq. ft. at a time to treat. Do not try to treat a larger area, because this will result in product drying on floor.

STEP 5: Using a clean mop, apply **RED-X** liberally on the area to be treated.

STEP 6: Scrub the floor-using a low speed buffer and a white pad with the product-to loosen the soil buildup and put the product into action. Keep the area treating wet and observe the area closely to make sure no spots become dry.

NOTE: DO NOT ALLOW THE FLOOR TO DRY.

STEP 7: After Dwell time tested above (*average is usually around 25-35 minutes, must pretest for correct time*) have elapsed, using a clean mop, pick up the dirty solution and thoroughly rinse the area with clean water, changing rinse water frequently. Make sure to keep mop head clean. You can use a wet vac to clean up the water.

STEP 8: Properly dispose of dirty solution and the **Red-X** container when empty.

STEP 9: Maintain floor daily using a commercial grade emulsifier degreaser.
Use as directed.
